ORDINANCE NO. 562

AN ORDINANCE AMENDING SECTIONS 145-30 (B)(1)(c) AND 145-30 (B)(2)
AND ADDING A NEW SECTION 145-30 (B)(1)(d) TO THE
CODE OF ORDINANCES OF THE BOROUGH OF LIGONIER
CONCERNING METERED PARKING

BE IT ORDAINED, and it is hereby enacted and ordained by the Council of the Borough of Ligonier in session lawfully assembled as follows:

SECTION I

Section 145-30 (B)(1)(c) of the Code of Ordinances of the Borough of Ligonier is hereby amended to read as follows:

Section 145-30 (B)(1)(c):

- (c) The monthly parking rates for parking permits in the municipal parking lots are established as follows:
- (1) \$30 per month for the North Market and Church Street lot designated as Lot A
 - (2) \$25 per month for the Pine Alley parking lot designated as Lot C
 - (3) \$20 per month for the South Market Street lot designated as Lot B
 - (4) \$15 per month for any resident of Ligonier Borough who is at least 70 years of age
 - (5) The Borough Council shall establish by rules and regulations the number and location of permit parking spaces in each lot and the days and hours during which the parking permits are valid.

SECTION II

Section 145-30 (B)(1) is hereby amended by adding thereto a new subparagraph (d) to read as follows:

Section 145-30 (B)(1)(d):

- (d) The monthly parking rates for a metered street parking permit restricted only to a Ligonier Borough resident who has no off-street parking at his or her residence are as follows:
- (1) \$20 per month with a ten (10%) percent discount if paid one year in advance
 - (2) \$15 per month for a Ligonier Borough resident over the age of 70 years with a ten (10%) percent discount if paid one year in advance
 - (3) The metered street parking permit is valid only on the Borough street on which the permit holder resides. No metered street parking permits shall be issued for East Main Street, West Main Street, North Market Street, South Market Street or the Diamond.
 - (4) The Borough Council shall establish rules and regulations setting forth the days and hours during which the parking permits are valid.

SECTION III

Section 145-30 (B)(2) is hereby amended to read as follows:

Section 145-30 (B)(2):

A reserved meter bag may be obtained from the Police Department or Borough Office under rules and regulations established by Borough Council for the rate of \$5 per day with at least a 24-hour prior request to the Police Department or Borough Office.

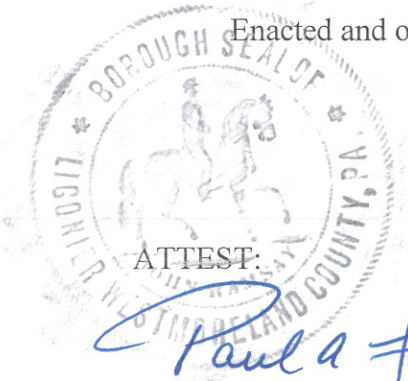
SECTION IV

All other provisions of Section 145-30 shall remain in effect and unchanged.

SECTION V

This ordinance shall become effective on July 1, 2014.
