
A word from the Ligonier Borough Secretary-Treasurer

Public Works Department

Leaf Pick Up began October 15 and will run as needed until December, Residents are reminded to please keep the leaves on the curb and off the streets.

Please take note that tree & shrubs extending over Borough streets & alleys must be trimmed back to the curb or to a height of 13'6".

Tar & Chip to return in 2021. A list of streets to be done will be posted on the Borough website / Savvy.

Dumpster Days @ Public Works Building for Ligonier Borough residents will be scheduled in the spring. Information will also be posted at a later date on the Borough website / Savvy.

Stormwater Management Ordinance

Residents filing building permits within the Borough for projects with a total impervious area over 1,000 square feet must now comply with the Stormwater Management Ordinance adopted June 2020. Please see the Borough website for Ordinance *#*576.

Winter Maintenance

As winter approaches residents are reminded that snow / ice must be removed from the sidewalks within 24 hours of a snow event.

The owner, occupant or tenant in the Commercial Districts are required to remove all snow / ice within six hours after a snow event. Snowfall after 6:00 pm may be removed by 10:00 am the next mornina.

Please DO NOT shovel snow onto the streets or alleys. This is a violation of PA Law & will cause hazardous conditions on the streets (PA C.S., Chapter 55).

Residents are asked to try to use off street parking during big snow events to aid Public Works crew with cleanup.

THE NOVEMBER 2020 ELECTION

The November 3rd General Election is quickly approaching. All registered voters interested in participating should make a plan as to how they want to cast their vote for the election.



Polling stations will be available for in person voting, but due to concerns regarding Covid-19, citizens may want to cast their vote by Mail In or Absentee ballot. Applications for Mail In or Absentee ballots are available now and may be completed online or downloaded to submit by mail or in person at the County Election Office. **Applications** to vote by mail must be received at the election office by no later than October 27th at 5 p.m.

The Supreme Court has ruled that postmarked Mail-In-Ballots received up to November 6, 2020 will be counted.
